

are either nursing home eligible or are dually eligible for both Medicare and Medicaid benefits. Alabama Select Network (ASN) began operation on October 1, 2028, as the single statewide Medicaid integrated care network (ICN) providing primary care case management for Medicaid beneficiaries eligible for long term care in Alabama's nursing homes or the Medicaid elderly and disabled and transitional care waiver forms. Beginning as of October 1, 2023, ASN was re-awarded its second ICN contract term of up to 5additional years. Richard is on the board and serves as chair of each of these entities.

He has been a member of the Board of Directors of the American Health Care Association and formerly was on the Executive Committee of the Advisory Board of the Jefferson County Health System. From 1978 to 1984, Richard served on Alabama's Statewide Health Coordinating Council, and for many years served on the Advisory Board of the National Investment Center for Senior Housing.

Richard is also active in the community, serving on the Boards and Committees of a number of local charities. From 1984 to 1986, he served as a member of the Editorial Staff of The American Journal of Trial Advocacy.
